**Target Organs**

Breathing isopropanol vapors has caused damage to the lining of the middle ear in experimental animals. The relevance of this finding to humans is uncertain. Overexposure to this material (or its components) has been suggested as a cause of the following effects in laboratory animals: mild reversible liver effects.

**Eyes**

If symptoms develop, immediately move individual away from exposure and into fresh air.

**7. HANDLING AND STORAGE****Handling**

Containers of this material may be hazardous when emptied. Since emptied containers retain product residues (vapor, liquid, and/or solid), all hazard precautions given in the data sheet must be observed. Avoid prolonged or frequently repeated skin contact with this material. Skin contact can be minimized by wearing impervious protective gloves. As with all products of this nature, good personal hygiene is essential.
